The bids will be opened in the presence of Bidders' representatives who choose to attend at **13.00 2076/03/10 BS.(2019/06/25)** at the Godawari Municipality, Office of the Godawari Municipal Executive, Bajrabarahi, Lalitpur. Bids must be valid for a period of 90 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.**1,84,000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days from the date of opening)
